I HAVE ALSO FOUND A COPY OF THE "INTERNATIONAL COVENANT ON CIVIL AND POLITICAL RIGHTS" IT IS FOUNDED ON THE PRINCIPLES OF THE UNIVERSAL DECLARATION OF HUMAN RIGHTS.

THE GOVERNMENT WILL BE FORCED TO TALK TO US. WHAT WE HAVE IS MORE DAMAGING THAN WEAPONS OF MASS DESTRUCTION AND CANNOT BE DESTROYED BY BOMBS AND SOLDIERS.

HOLD ON TO YOUR PATIENCE BECAUSE TOGETHER WE CAN ACHIEVE GREATNESS. MOST DEMOCRACIES ARE ACHIEVED THROUGH VIOLENCE, BUT WE HAVE THE POWER TO CREATE CHANGE WITHOUT SHEDDING A SINGLE DROP OF BLOOD.

I AM CONFIDENT, BECAUSE MY IMPRISONMENT IS UNLAWFUL UNDER UK LAW, NATIONAL AND INTERNATIONAL LAW, AND IF NECESSARY I WILL PURSUE ALL AVENUES TO SECURE JUSTICE, BUT I WILL ALWAYS REQUIRE YOU BESIDE ME.

I AM VERY PROUD AND GRATEFUL FOR ALL YOUR EFFORT AND I CAN ASSURE YOU IT WILL NOT BE IN VAIN.

I WILL SEND YOU A COPY OF WHAT I HAVE AS SOON AS I'M ABLE TO HAVE IT COPIED

FOR NOW MY BROTHER KEEP UP THE GOOD WORK AND TAKE CARE OF YOURSELF.
