DEAR COMMISSION,

THE CREDIBILITY OF THE INDEPENDENCE AND IMPARTIALITY OF THE CCRC WILL BE CAST INTO SERIOUS DOUBT IF THE GRAVITY OF THIS APPLICATION IS NOT DEALT WITH EXPEDITIOUSLY.

THERE IS NOTHING MORE SERIOUS, IN A DEMOCRATIC SOCIETY, THAN WHEN THE RULE OF LAW IS THREATENED, AND MORE SO, WHEN THREATENED BY MEMBERS OF THE JUDICIARY.

WHILST I CAN APPRECIATE THAT THERE ARE MANY APPLICANTS CLAIMING A MISARRIAGE OF JUSTICE, AND WHO ARE DESERVING OF REVIEW, I CANNOT BELIEVE THAT THERE ARE ANY APPLICATION AS SERIOUS AS MY OWN, OTHERWISE, THE JUDICIARY MUST BE INVOLVED IN A MUCH MORE SERIOUS LEVEL OF CORRUPTION THAN IS EXPOSED IN MY OWN APPLICATION.

JUSTICE DELAYED IS JUSTICE DENIED AND ALTHOUGH I'VE ONLY SPENT TWO YEARS IN PRISON, THE BACKGROUND OF THIS MATTER STEMS FROM THE TRAGEDY OF A CHILD'S DEATH WHICH DATES BACK ELEVEN YEARS.

THE LAW ALLOWS NO JUSTIFICATION FOR TORTURE, YET  
SINCE THE DEATH OF MY CHILD I HAVE BEEN SUBJECTED  
TO THE MOST HORRENDOUS DEGREE OF TORTURE AT THE  
HANDS OF THE JUDICIARY.

HOW WILL THE WORLD REGARD BRITISH JUSTICE IF THE  
 CERC DOES NOT TREAT THIS MATTER WITH THE LEVEL  
 OF URGENCY IT DESERVES?

HOW WILL THE STATE RE-BUILD PUBLIC CONFIDENCE IN  
 THE CRIMINAL JUSTICE SYSTEM AND THE RULE OF LAW  
 IF THIS MATTER IS TREATED LIKE ANY OTHER, AS THOUGH  
 IT'S AN EVERYDAY OCCURRENCE.


IT WOULD BE EXTREMELY SHAMEFUL AND VERY TRAGIC
