**REF: Unlawful Detainment & False Imprisonment Owing To  
Unprecedented Levels Of Judicial Corruption & Improprieties,  
Existing Government Authority Has Failed To Take Serious,  
Amidst Ongoing Omissions.**

First I like to congratulate you on archiving leadership of the new Conservative Party which we hope will in fact be rid of the deeply rooted racist within the fold that thinks that only the affairs and interest of White People alone need be represented by modern UK state government establishments and institutions.

**I hope unlike your predecessor (Micheal Howard) who when approached by this campaign with facts and evidence of unprecedented levels of Judicial corruption and improprieties, responsible for False and Unlawful Imprisonment of a citizen, will not amateurishly dismiss this matter, as he did in bad judgement and utter contempt for the issues entailed therein.**

Mr. Grant have been fighting an injustice which resulted in his False Imprisonment since 1998, following the corrupt practice resulting from Justice Toulson granting an ex parte application to his brother's Law Firm (who were the party Mr. Grant was suing for several breaches of the Solicitors Code of Conduct).

In order to disguise the gross breach and transgression, Justice A K Toulson and his brother, Mr. Alan Toulson of Reynolds Porter Chamberlain, have since immerse themselves in conspiracy to Deny Mr. Grant Justice and Redress for their Abuse of process and procedure.

However at this point, it is equally important to emphasis we do not claim all Judges to be corrupt, nor is it all Lawyers and Law Firms. As a matter of fact it is a corrupt few of influence within the system that is dishonourable and without integrity. They are the same few who tried to influence the abolishment of Trial by Jury, so that there would be no neutral and independent ways of bringing them to book for ongoing breaches and improprieties of the likes this campaign hold evidence of.


