**RE: Mr. Caul Silford Grant: (Prison Remand No. JC8360)**  
**Ref: Unresolved Matters of State Lawbreaking, Judicial Corruption and Unlawful Imprisonments**

After having notified you; the Prime Minister; the Attorney General; the Lord Chancellor and the Commissioner of Police, (through several correspondences) of ongoing corruption in the Judiciary which continue to deny Mr. Grant. re-dress for his Unlawful Imprisonment in February 1999 by Justice Toulson in granting an ex-pate application strategically placed before him to preside over by his brother's law firm. (Reynolds Porter Chamberlain)

As you should know by now (had you taken this matter seriously and made appropriate investigative enquiries) Reynolds Porter Chamberlain were representing parties Mr. Grant was suing for false advise and several breaches of the Solicitors Codes of Conduct at the time and presenting an application for a restraining order against Mr. Grant before a presiding relative to rule over was a serious breach of the right to a fair, independent and impartial hearing under Article 6 of the Convention on Human Rights. It was also a criminal conduct and a blatant abuse of power, which even common sense informs should have warranted immediate investigation and arrest. rather than a persistent attempt by You, the Prime Minister; the Attorney General; the Lord Chancellor and the Commissioner of Police to sweep it all under the carpet and pretend it never happened.

The fact remain, that the whole thing did happen and Mr. Grant has had to get Her Majesty the Queen involved in the matter. Her Majesty's letter dated 9<sup>th</sup> January 1998 (enclosed) should have been enough to warrant adequate checks and restraints. but instead we find officers of the crown in public places such as the former Lord Chancellor, Lord Irvine of Lairg failing even then to act, choosing instead to serve and protect the interest of his friends and corrupt colleagues in the Legal profession, ahead of duty and oath of the office charged him to administer. This is what have lead to the recent abolition of his office and a near 1500 year old history despite the Prime Minister's compulsive spins, lies and disinformation to the public as to the real reason behind such a


drastic action which compared very much to booting out the pilot while the plane is still in mid air.

Well the fact is Mr. Grant is now being held in custody as a consequence of his sworn determination to expose the corruption and injustices, affecting him and responsible for his unlawful imprisonment. As a campaigning group who have been out there to see and test both the accounts and experience of Mr. Grant for ourselves, we can confirm that there is a corrupt few within the Judicial System with connection, who have continuously ensued that Mr. Grant never attain access beyond the lower (Magistrates) courts where there friends remain overwhelmingly in control. Seeing that his access to the courts were being artificially blocked by corrupt criminal quangos in the legal establishments including the Crown Prosecution Service, Mr. Grant have sworn to find a way to get into the High Court to get his day, no matter what it takes.

Now from the confines of the prison walls, Mr. Grant has had to involve Her Majesty The Queen once again. The approach to Her Majesty was well received and we know from the contents of HRM's communicated response to Mr. Grant in HMP High Down, that you and your office can no longer claim ignorance, as you have been doing for so long to protect your friends corrupt friends, since Her Majesty herself have now referred the matter to you at the Home Office.

In close, I assure you that we are sincerely here to expose you, your deceitful Prime Minister, his corrupt Government, Friends and Colleagues in the legal profession responsible for bringing the Monarch as well as the Legal profession in to disrupt.
